# CONSOLIDATION OF IGLOOLIK LIQUOR RESTRICTION REGULATIONS

R.R.N.W.T. 1990, c.L-30

AS AMENDED BY

This consolidation is not an official statement of the law. It is an office consolidation prepared for convenience of reference only. The authoritative text of regulations can be ascertained from the *Revised Regulations of the Northwest Territories*, 1990 and the monthly publication of Part II of the *Northwest Territories Gazette* (for regulations made before April 1, 1999) and Part II of the *Nunavut Gazette* (for regulations made on or after April 1, 1999).

## Liquor Act (Nunavut)

## Igloolik Liquor Restriction Regulations

- **1** For the purposes of these regulations, Igloolik shall be deemed to consist of the whole of Igloolik Island in the Territories, as shown in the Department of National Defence, Mapping and Charting Establishment Map 47D/7 1:50,000.
- 2 In these regulations "Committee" means the Alcohol Education Committee referred to in section 3.
- **3**(1) There shall be an Igloolik Alcohol Education Committee whose functions shall include the education and counselling of persons in the use of alcohol for the prevention of alcohol abuse.
- (2) The Committee shall consist of eight persons who shall be elected publicly for a two year term in the same manner as the election of members of the Igloolik Hamlet Council under the *Local Authorities Elections Act* and their term shall commence on the first day of January next following their election.
- (3) The Committee shall elect from its members a chairperson, vice-chairperson and secretary.
- **4** Every person who desires to order liquor in Igloolik, or to import of bring liquor into Igloolik, shall apply to the Committee for approval.
- **5**(1) The rules of procedure to be followed by the Committee for receipt, consideration and disposition of applications shall be as set out in the Schedule to these regulations.
- (2) The Committee may establish rules for regulating its proceedings provided that the rules are not inconsistent with the Act or these regulations.
- **6**(1) The Committee may approve or reject any application in whole or in part.
- (2) The decision of the Committee shall be noted on each application, accompanied by the signature of the chairperson, vice-chairperson or secretary, and stamped with the seal of the Committee.
- **7**(1) Any person aggrieved by a decision of the Committee may appeal to a justice of the peace for Igloolik.
- (2) On appeal, the justice of the peace, after hearing the parties and such evidence that he or she considers relevant, may vary, confirm or overrule the decision of the Committee and the Committee shall give effect to that decision.
- 8 No person shall
  - (a) order liquor in Igloolik, or
  - (b) import or bring liquor into Igloolik

without the approval of the Committee.

- **9** No person shall possess liquor which has been imported or brought into Igloolik in contravention of these regulations.
- 10 Every person who contravenes section 8 or 9 is guilty of an offence and liable on summary conviction to a maximum fine of \$500 or to a maximum sentence of six months in jail or to both.

#### SCHEDULE (Subsection 5(1))

#### RULES OF PROCEDURE

- 1 An application to the Committee shall be in such written form as is from time to time approved by the Committee and forwarded to the chairperson or secretary of the Committee.
- 2 The chairperson shall call such meetings of the Committee as are required to deal with applications received and shall advise each applicant as to when the application is to be considered.
- **3** Meetings of the Committee to consider applications shall be held at the Council Chambers in Igloolik. An applicant shall have the right to attend and be heard at the meeting at which his or her application is to be considered.
- **4** The secretary shall keep minutes of all meetings to consider applications, including records of approved and rejected applications, which records shall be treated as confidential.
- **5** A quorum of the Committee shall consist of five members personally present.
- **6** Decisions of the Committee shall be by majority vote of the members personally present. In the event of a tie vote, the chairperson shall have a deciding vote.
- 7 A member of the Committee shall declare any interest in an application and shall not vote on an application in which he or she or any member of his or her family has an interest.
- **8** An application may be partially approved or rejected where an applicant has, in the opinion of the Committee, caused problems to his or her family, friends or to the community as the result of the use of liquor.
- **9** Where an application has been approved or partially approved, the approved quantities of liquor shall be noted on the application and initialled.
- 10 Where an application has been partially approved or rejected, the chairperson shall, if requested by the applicant, advice the applicant of the reasons for the decision of the Committee.
