## Financial Assistance for Nunavut Students

# RENT SUPPLEMENT APPLICATION COVER PAGE

## ELIGIBILITY

---

The rent supplement is available to full-time post-secondary students eligible to receive the FANS supplementary grant who pay rent for accommodations while enrolled at a post-secondary education institution either:

- Outside of Nunavut; or
- In a Nunavut community other than their home community and:
  - Have dependants living with them in their school residence or private accommodations; or
  - Are a single student renting in private accommodations.

**Note:** Government of Nunavut staff housing, public housing, and mortgages are not eligible

**Note:** The Rent Supplement is only available for the months you are renting while enrolled in a full-time program and receiving the supplementary grant

## INSTRUCTIONS

---

The rent supplement is available to full-time post-secondary students eligible to receive the FANS supplementary grant who pay rent for accommodations while enrolled at a post-secondary education institution either:

- Complete this form and submit it and your rental document to [fans@gov.nu.ca](mailto:fans@gov.nu.ca)
- FANS will review your application and notify you of your eligibility for this supplement
- If approved, you must notify FANS immediately of any changes to your living arrangements and may need to submit additional information or documentation
- This application must be submitted before the end of the semester. Funding cannot be issued retroactively for previous semesters

You must submit a copy of an approved rental document with this application. Examples of an approved rental document are a lease, a rental agreement, a university residence lease agreement etc. This document must identify:

- You as the tenant;
- Your rental address;
- The monthly amount you pay in rent; and
- The term or time period of your rental.

<p>I, _____ (Full Name), of _____ (Community), Nunavut, understand that I will only receive monthly rent supplements for the months during which I am enrolled as a full-time post-secondary student and an eligible recipient of the supplementary grant. I understand that I will not begin to receive monthly rent supplements from FANS until my Student Enrolment Form (SEF) or NAC EV (if I'm a NAC student) is submitted.</p> <p>I understand that FANS will conduct regular audits of my student file and may ask for supporting documents to verify the information I submit. I understand that if I receive monthly rent supplements for which I am not eligible, these will be considered overpayments that I will be responsible for repaying to FANS. Similarly, if it is found that I receive monthly rent supplements that are greater than the amount I actually pay in rent, I will be responsible for repaying the difference to FANS.</p> <p><b>I understand that if it is found that I have received overpayments, I may be ineligible for FANS benefits in the future.</b></p> <p>I confirm that I will not be receiving monthly rent supplements to pay for a Government of Nunavut public or staff housing unit that has been sublet. <b>If it is found that this is the case, the situation may be referred to the Nunavut Housing Corporation for investigation.</b></p> <p>I understand that I must inform FANS and resubmit this application and accompanying rental documents if any of the above information changes during the academic year.</p>
