

CABINET APPOINTMENTS POLICY

# **EXECUTIVE & INTERGOVERNMENTAL AFFAIRS**

## PURPOSE

The Government of Nunavut is committed to an appointment process that is easy to understand, fair, transparent, and is reflective of Inuit societal values.

The Cabinet Appointments Policy sets out requirements for Cabinet approval of certain statutory and non-statutory appointments and designations of high interest.

## PRINCIPLES

This policy is based on the following principles:

- Nunavummiut deserve accountable representation from public territorial boards, agencies, committees, councils, and tribunals, as well as by those appointed to positions of influence.
- Nunavummiut deserve the most qualified individuals to serve on public territorial boards, agencies, committees, councils, and tribunals. These qualifications will take into consideration knowledge of the social and cultural milieu of Nunavut.
- The Government of Nunavut is committed to being an open, responsive, and accountable government.

## APPLICATION

This policy applies to all departments and agencies of the Government of Nunavut.

## DEFINITIONS

<u>Board</u>

Means a board, committee, tribunal, council or commission.

## Cabinet Designated Appointment

An appointment that requires Cabinet approval prior to an individual being appointed or recommended for appointment to a board or position. These appointments are listed in Appendix A of this policy, which is subject to amendments from time to time by Cabinet.

Cabinet Designated Appointments are appointments to positions that:

- grant decision-making authority; or
- relate to vulnerable groups; or
- place members on boards, agencies, committees, land claims boards or intergovernmental committees, or committees formed under the Nunavut Agreement; or,
- have been deemed by Cabinet as requiring their collective approval.

## Commissioner

The Commissioner of Nunavut appointed under section 5(1) of the Nunavut Act.

## <u>Department</u>

Means a department, territorial corporation, or public agency of the Government of Nunavut.

#### Chief Legislative Counsel

The Chief Legislative Counsel appointed under paragraph 78(1)(a) of the *Legislation Act.* 

## **Revocation of Appointment**

A revocation of an appointment is required where the appointment is terminated before the end of the appointment term or when a person retires or resigns from a position with an indefinite term. A revocation is also needed in those cases where the relevant Act states that the incumbent retains their appointment until they are replaced, even though their term has expired. In each case a revocation is required to allow the position to become vacant.

#### Standard Appointment

An appointment that does not require Cabinet approval prior to an individual being appointed to a board or position.

#### Nunavut Resident

An individual must be a resident of Nunavut for at least twelve months to qualify for consideration under this Policy.

## ROLES AND RESPONSIBILITIES

#### <u>Cabinet</u>

Cabinet will review the designation of all appointments at the beginning of each new government and may review at other times as desired.

#### Premier

Subject to Cabinet approval, the Premier will have the prerogative to appoint all persons of Deputy Head rank, excluding the Clerk of the Legislative Assembly. Some Acts constituting public agencies also require a recommendation of or consultation with the Board of the public agency for appointments and revocations of the deputy head of the public agencies.

#### <u>Ministers</u>

Ministers are the legally responsible actors designated to make appointments under territorial legislation, unless otherwise stated.

## Deputy Heads

Deputy Heads are accountable for the implementation of this policy.

### Executive and Intergovernmental Affairs

Executive and Intergovernmental Affairs is responsible for administration of this policy.

Department of Justice

The Department of Justice will prepare appointments and publish appointments in the Nunavut Gazette.

## PROVISIONS

- 1. <u>Timing of Appointments</u>
  - a) A statutory appointment or reappointment is required when the number of board members falls below the necessary minimum, established in the relevant legislation or terms of reference. Other appointments or reappointments are required as specified in the relevant instrument.
  - b) A statutory appointment or reappointment may also be required when the number of appointees falls below a number necessary for effective implementation of a statutory requirement.
  - c) A department may request to backdate a statutory appointment a maximum of three months, in accordance with subsection 29(4) of the *Legislation Act*. An appointment to or a revocation from a quasi-judicial office may not be effective before the day it is made. Certain actions of an appointee undertaken during the period before the appointment was made are not validated by the appointment, in accordance with subsection 29(4.2).

## 2. Procedure for Appointments

- a) Where an appointment, reappointment or revocation is necessary or desired, the relevant department will consult Appendix A to determine if it is a Cabinet Designated Appointment. If the appointment is not on Appendix A, then it is a Standard Appointment which does not require Cabinet approval.
- b) A public call for nominations shall be issued for all board appointments. If a public call was issued within a year, nominations may be sought from that list of interested candidates.
- c) Renewal of current members on a board will be considered at the same time as any new appointments to a board based on the public call.

- d) The appointment of board members will be restricted to Nunavut Residents (minimum 12-month residency in Nunavut), unless special circumstances require expertise not available in Nunavut (ex. professional designation as a psychiatrist).
- e) Unless otherwise provided by law, qualified candidates shall be considered in accordance with the following priority ranking categories:
  - i. Inuit residing in Nunavut;
  - ii. Other Nunavut Residents.
- f) In accordance with Section 203 of the Human Resources Manual, if a selected candidate is a GN employee, the candidate must obtain approval from the candidate's Deputy Minister prior to preparation of the submission to Cabinet.
- g) The Chief Legislative Counsel will prepare appointment forms for signature for all statutory appointments to be signed by a Minister or the Commissioner. Some Cabinet Designated Appointments are not statutory appointments (ex. Nunavut Agreement appointments) and therefore do not require appointment forms prepared by the Chief Legislative Counsel.

## 3. Cabinet Designated Appointment

- a) All appointments and revocations listed as Cabinet Designated Appointments in Appendix A require approval from Executive Council.
- b) The department will prepare a Request for Decision for Cabinet consideration. The Request for Decision shall include the following:
  - If the appointment is to a board, a short description of the board's function;
  - If the appointment is to a board, the current composition of the board which includes each members' residency, their appointment dates and term of the appointment;
  - A short resume of the suggested appointee(s);
  - If the suggested appointee(s) is employed by the Government of Nunavut or any of its Agencies, either a copy of the Deputy Minister approval (as per HRM 203) or a statement confirming that the appropriate Deputy Minister has granted approval for the appointment.
  - A list of all applicants from the most recent public call for nominations;
  - The appointment request forms submitted to Justice by the department (if it is a Statutory Appointment); and
  - The appointment forms (blue corner documents) prepared by Justice (if it is a Statutory Appointment).
- c) In the case where several Cabinet Designated Appointments and/or revocations are requested at the same time and under the same statutory instrument (e.g. Justices of the Peace Act), one Request for Decision should be prepared and submitted.

## 4. Standard Appointment

- a) Appointments and revocations not listed in Appendix A are Standard Appointments (do not require Cabinet approval). Appointments to be signed by a Minister or the Commissioner will be prepared by the Legislation Division of the Department of Justice.
- b) For these appointments, departments or agencies will follow the process in the appropriate legislation or regulation. The relevant Minister or the Commissioner will sign the appointment forms. The Chief Legislative Counsel registers the appointment and publishes it in the Nunavut Gazette.

## 5. <u>New Appointments</u>

- a) Newly established appointments are typically deemed to be Standard Appointments.
- b) When a new high interest appointment (statutory or non-statutory) is established, the relevant department or agency should consult with the Secretary to Cabinet. The Secretary to Cabinet will bring the matter to the Premier and it will be considered by Cabinet if deemed appropriate.
- c) If Cabinet decides that a particular appointment is to be a Cabinet Designated Appointment, the list of appointments requiring Cabinet approval will be updated accordingly.
- 6. <u>Reporting</u>
  - a) All statutory appointments signed by a Minister or the Commissioner will be published in the Nunavut Gazette.
  - b) The Nunavut Gazette is prepared and published by the Department of Justice, Legislation Division.

## PREROGATIVE OF EXECUTIVE COUNCIL

Nothing in this directive shall in any way be construed to limit the prerogative of Executive Council to make decisions or take action respecting the appointments process of the Government of Nunavut, outside the provisions of this policy.

## SUNSET

This Policy will be effective from the date of approval until December 31, 2025.
